ISO 9001 Certification : this international standard defines the criteria for a quality management system (QMS). It is designed to help organisations ensure that they meet customer and regulatory requirements while continuously improving their performance.



ISO 45001 Certification : this international standard establishes the criteria for an occupational health and safety (OHS) management system. It aims to help organisations create a safe and healthy working environment, by reducing the risks associated with occupational accidents and illnesses.




Well-being at work through mental health programmes, team-building activities and flexible teleworking policies creates a rewarding and supportive environment for every employee.



This declaration presents essential data on the environmental impact of a product in a standard format.

The EPD issued is an independently verified document. It reliably communicates transparent and comparable information about the environmental effects of a full range of filters throughout their life cycle.

They currently provide a numerical representation of a product's environmental impact, which is why EPDs are mainly used in B2B relationships.



In 2022, we sent our Supplier and Ethics Charter to all our partners, asking them to commit to our values. This commitment continued in 2023, with a follow-up to ensure compliance with our ethical and sustainability standards.
